**COUNTY OF ALLEGHENY
PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION**

Shall the Allegheny County Home Rule Charter be amended to establish the Allegheny County Children's Fund, funded by Allegheny County levying and collecting an additional 0.25 mills, the equivalent of \$25.00 on each \$100,000 of assessed value, on all taxable real estate, beginning January 1, 2019 and thereafter, to be used to improve the wellbeing of children through the provision of services throughout the County including early childhood learning, after school programs, and nutritious meals.

EXPLANATION OF BALLOT QUESTION

If this question is approved by a majority of those voting, The Allegheny County Home Rule Charter shall be amended to create an annual tax on taxable real estate in Allegheny County in the amount of 0.25 mills. This tax increase would be the equivalent of \$25.00 per \$100,000 of assessed real estate valuation. The resulting revenue would be used to establish the Allegheny County Children's Fund and used to improve the well-being of children through the provision of services throughout the County, including early childhood learning, after school programs, and nutritious meals.

The question would also establish the Office of the Allegheny County Children's Fund to administer the Allegheny County Children's fund. The Office of the Allegheny County Children's fund would be supervised by the Allegheny County Manager. The Chief Executive and County Council would then create an Allegheny County Children's Fund Citizen's Advisory Commission to review and advise the operation of the Office of the Allegheny County Children's Fund.

If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election.

**MUNICIPALITY OF BETHEL PARK
PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #1**

Shall Article 14, General Provisions, of the Bethel Park Home Rule Charter be amended to include a new Section, entitled References to Gender, which provides that all references to the male gender within the Home Rule Charter are deemed to refer to the male and female gender?

EXPLANATION OF BALLOT QUESTION #1

If this question is approved by a majority of those voting, Section 1409, References to Gender shall be added to the Charter, to provide that all male reference in the Charter be viewed as "gender neutral".

If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.

**MUNICIPALITY OF BETHEL PARK
PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #2**

Shall Article 12, Sections 1201(B) Referendum, and 1205, Referendum Petitions; Suspension of Effective Date of Ordinance, of the Municipality of Bethel Park Home Rule Charter be amended to state that when residents initiate referendum procedures challenging ordinances increasing or decreasing a tax rate, the increase or decrease will be challenged without suspending the tax rate in effect prior to the ordinance? The prior tax rate shall continue until final disposition of the referendum challenge.

EXPLANATION OF BALLOT QUESTION #2

If this question is approved by a majority of those voting, Article 12, Sections 1201(B) Referendum and 1205, Referendum Petition; Suspension of Effective Date of Ordinance of the Charter shall be amended by incorporating language that permits a challenge to an ordinance, as to the amount of the tax rate increase or decrease without suspending the rate in effect prior to the ordinance. The prior tax rate shall remain unchanged pending final disposition of the challenge. If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.

PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #3**

Shall Article 12, Section 1204, Procedure After Filing Petitions, of the Municipality of Bethel Park, Home Rule Charter be amended by removing the provisions allowing a petitioner additional time to amend an initiative or referendum petition deemed insufficient by the Municipal Manager?

EXPLANATION OF BALLOT QUESTION #3

If this question is approved by a majority of those voting, Article 12, Section 1204, Procedure After Filing Petitions of the Charter shall be amended to delete the process of allowing a petitioner additional time to revise an initiative or referendum petition certified as insufficient by the Municipal Manager. If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.

**MUNICIPALITY OF BETHEL PARK
PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #4**

Shall Article 12, Section 1204(B) Council Review of the Municipality of Bethel Park Home Rule Charter be amended to state that a petitioner must provide sufficient security upon filing for court review of Council's determination as to the insufficiency of an initiative or referendum petition?

EXPLANATION OF BALLOT QUESTION #4

If this question is approved by a majority of those voting, Article 12, Section 1204(B), Council Review, of the Charter will be amended by requiring the petitioner to post sufficient security in the Court of Common Pleas to cover the costs of challenging Council's final findings of an insufficient Initiative or Referendum Petition. The language currently states "insufficient security". If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.

**MUNICIPALITY OF MONROEVILLE
PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #1**

Shall Article XIII. Treasurer, of the Monroeville Home Rule Charter, be amended to permit Monroeville Council to combine the offices of Treasurer and elected Tax Collector, appoint the Treasurer for an indefinite time and define the Qualifications, Purpose, Duties and Responsibilities of the Treasurer, as more fully described in Monroeville Ordinance No. 2667?

EXPLANATION OF BALLOT QUESTION #1

If this question is approved by a majority of those voting, Article XIII. Treasurer, of the Monroeville Home Rule Charter shall be amended to permit Monroeville Council to combine the offices of Treasurer and elected Tax Collector, appoint the Treasurer for an indefinite period of time and establish residency, age and educational requirements. Currently, the Treasurer may be appointed for a term not to exceed two (2) years. The office of elected Tax Collector shall be abolished.

Article XIII shall also be amended to establish the purpose, duties and responsibilities of the Treasurer, who shall be responsible for all fiscal functions, records and systems and shall plan, coordinate and administer the risk and insurance programs and monitor all purchasing activities of the Municipality in accordance with applicable law. The Treasurer shall also be responsible for financial advice, internal controls and requested reports, the collection and deposit of taxes, fees and other receipts, accounts payables, payroll, services billings and the records needed for the payment of the debts and obligations of the Municipality of Monroeville.

If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.

**MUNICIPALITY OF MONROEVILLE
PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #2**

Shall Article XIV. Contracts, of the Monroeville Home Rule Charter be amended to increase the threshold amounts for contracts that must be competitively bid for labor, material supplies or services and insurance, professional and unusual services to the amounts provided for by Pennsylvania law and permit contracts for supplies to exceed two (2) years and provide the Solicitor the option to cure invalid contracts, as more fully described in Ordinance No. 2667?

EXPLANATION OF BALLOT QUESTION #2

If this question is approved by a majority of those voting, Article XIV. Contracts, of the Monroeville Home Rule Charter shall be amended to increase the threshold dollar amount for competitively bid contracts from \$4,000 to \$10,500 for written or telephonic quotes and to \$20,100 for publicly advertised bids, in accordance with Pennsylvania law. The law further provides for adjustments to bid amounts due to inflation per the (CPI) Consumer Price Index. Contract amounts less than \$10,500 shall not require formal bidding or written/telephonic quotes.

The Charter shall also be amended by deleting the two-year maximum term limitation for contracts for the purchase of supplies and provide the Solicitor the option to cure invalid contracts.

If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.

**MUNICIPALITY OF MONROEVILLE
PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #3**

Shall Article XVII. Investigative, Hearing and Subpoena Powers, of the Monroeville Home Rule Charter be amended to permit the issuance of subpoenas to out of state parties and impose penalties consistent with Pennsylvania law for parties that do not obey a subpoena?

EXPLANATION OF BALLOT QUESTION #3

If this question is approved by a majority of those voting, Article XVII. Investigative, Hearing and Subpoena Powers, of the Monroeville Home Rule Charter shall be amended to permit the issuance of subpoenas to compel the attendance of witnesses and the production of evidence pursuant to Pennsylvania law. Currently, the Charter only permits the issuance of subpoenas to be served within the Commonwealth of Pennsylvania.

In addition, Article XVII, shall be amended to permit the imposition of fines, costs and sanctions, pursuant to Pennsylvania law, upon parties who refuse or neglect to obey a subpoena.

If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.

**MUNICIPALITY OF MONROEVILLE
PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #4**

Shall Article XXI. General, of the Monroeville Home Rule Charter be amended to require that a vacancy in the Office of Member of Council may only be filled at a Municipal Election, pursuant to the provisions of the Pennsylvania Election Code?

EXPLANATION OF BALLOT QUESTION #4

If this question is approved by a majority of those voting, Article XXI. General, of the Monroeville Home Rule Charter shall be amended to require that a vacancy in the Office of Member of Council may only be filled at a Municipal (odd-numbered year) Election, in accordance with the provisions of the Pennsylvania Election Code. Currently, the Charter permits the filling of a Council vacancy at any election.

If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.

SPECIAL ELECTION QUESTION #5**

Shall Article XXIV. Recall, of the Monroeville Home Rule Charter be deleted?

EXPLANATION OF BALLOT QUESTION #5

If this question is approved by a majority of those voting, Article XXIV, Recall provisions of the Monroeville Home Rule Charter shall be removed. Any removal from office would be pursuant to the procedures set forth in the Pennsylvania Constitution.

If approved, this amendment shall take effect upon certification of the November 6, 2018 General Election results.

**WEST DEER TOWNSHIP
PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #1**

Shall Section C-1015 of the West Deer Township Home Rule Charter be amended to permit Township Supervisors to be compensated at the rate of \$50.00 per month, as more fully described in Township Ordinance No. 423?

EXPLANATION OF BALLOT QUESTION #1

If this question is approved by a majority of those voting, the West Deer Home Rule Charter shall be amended to permit Township Supervisors to be paid \$50.00 per month. This rate may be changed by ordinance but shall not become effective until the first day of the year following the election of Supervisors. Township Supervisors may not receive any other direct or indirect compensation. Any reimbursement for travel or other necessary expenses or other necessary expenses is limited to the Township Supervisors, upon approval by a majority vote of the Board of Supervisors.

If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.

PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #2**

Shall Section C-1019 of the West Deer Township Home Rule Charter be amended to replace language regarding Supervisor vacancies and removal from office that was found to be unconstitutional?

EXPLANATION OF BALLOT QUESTION #2

If this question is approved by a majority of those voting, the West Deer Home Rule Charter shall be amended to provide that a Township Supervisor shall only be removed from office by impeachment or conviction of an infamous crime, as provided for in the Pennsylvania Constitution.

If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.

**WEST DEER TOWNSHIP
PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #3**

Shall Sections C-1012, C-1016, C-1018 and C-1021 of the West Deer Township Home Rule Charter be amended by replacing all gender-specific, time-based and grammatically incorrect language?

EXPLANATION OF BALLOT QUESTION #3

If this question is approved by a majority of those voting, Sections C-1012, C-1016, C-1018 and C-1021 of the West Deer Home Rule Charter shall be amended by replacing the words "he" with "they", "his" with "their", "Chairman" with "Chairperson" and "Vice Chairman" with "Vice Chair" and removing the requirement that the Board organization meeting occur at 8:00 p.m.

If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.

**WEST DEER TOWNSHIP
PROPOSED HOME RULE CHARTER AMENDMENT
SPECIAL ELECTION QUESTION #4**

Shall Section C-1054 of the West Deer Township Home Rule Charter be amended to restate the list of actions which require an Ordinance, as more fully described in Township Ordinance No. 426?

EXPLANATION OF QUESTION #4

If this question is approved by a majority of those voting, Section C-1054 of the Home Rule Charter shall be amended by deleting "Establish wages, hours or fringe benefits of any employee of the Township".

If approved, this amendment shall take effect upon the certification of the November 6, 2018 General Election results.
