In accordance with the general provisions of the Election Code, notice is hereby given to the electors of the 35th State House District, that a Special Election will be held in said district on Tuesday, January 23, 2018, between the hours of 7:00 a.m. and 8:00 p.m., prevailing time, at the several election districts therein.

The 35th State House District is composed of the following: Clairton, Duquesne, Lincoln, McKeesport, Munhall, South Versailles, Versailles, West Mifflin (Districts 3, 4, 12, 15 and 16), Whitaker and White Oak.

The vacancy to be filled is for the remainder of the term expiring November 30th, 2018. The names of the candidates for election and the polling places are hereinafter set forth.
