The Ordinance is summarized as follows:

Article 1 defines certain terms, including the Bonds and the Project, which consists generally of payment of the costs of: (a) the design, construction and acquisition of the Borough's sanitary sewer system; (b) if necessary, the funding of interest on the Bonds for a period not exceeding the period of construction, plus one year, (c) funding a debt service reserve fund; and (d) issuing the Bonds.

Articles 2 and 3 authorize the incurrence of nonelectoral debt by the issuance of Guaranteed Revenue Bonds, establish a sinking fund and pledge the receipts and revenues from its sewer system together with its full faith, credit and taxing power of the Borough to the payment of the Bonds.

Article 4 provides the form, maturity amounts, interest rates and the terms and provisions for the payment of the Bonds. Articles 5, 6, 7 and 8 address the Sinking Fund Depository, events of default, and amendment and discharge of the security documents.

Article 9 contains federal income tax covenants; Article 10, securities law covenants.

Article 11 provides for general covenants with respect to the Bonds and the sewer system. Article 12 provides for the sale of the Bonds, establishes certain funds and sets forth certain directions for Settlement, while Article 13 authorizes other related and necessary actions.
